G. REGIONAL DELEGATE TEAM: Chris K & Bill O

Dear Family, The Delegate Team attended the Midwest Zonal Forum on July 24-26. WB member Craig R, and Special Worker Chris C. were present to facilitate a full day of workshops on Saturday. The day began with a NAWS update. This was an open forum question and answer session. The following is a summary of the information:

1. Service System Project: This is a 4 year project. One of its goals is to propose revisions to the NAWS Vision Statement, to make it a more "holistic", or global, World Vision Statement. This project will also help to create new tools and manuals for our service use. NAWS is asking for our Regions, Areas, and Groups to send their "best practices" to NAWS. "What do you do in your community to improve service delivery?"
2. "Self Support" and "In Time of Illness": Both of these pieces are being finalized for inclusion in the CAR. The review and input period has ended. There was little input from the Fellowship on either of these pieces. The final drafts will be published in the CAR for Fellowship approval at WSC 2010.
 - a. "Self Support" has been divided into two separate pieces. The first piece, "Keeping It" is meant to express the importance of individual contributions and to clarify the ownership and responsibility that come with NA membership. The second piece, "Giving it Away" is meant in part to illustrate the role of the group as part of NA as a whole and to convey the importance of group contributions to fund NA services.
 - b. "In Times of Illness" contains specific sections that address mental health issues, chronic illness, chronic pain, terminal illness, and supporting members with an illness.
3. Financial update: Donations to NAWS are about \$100,000 ahead of last year. Expenses are far outstripping income. NAWS provided \$625,000 in free or subsidized literature last year. Fellowship contributions are about \$220,000 under budget for the year. June contributions were \$100,000 for the first time this year. The NAWS annual report for the July 2007 to June 2008 is available online. The 2008-2009 report will be available by the end of the year. NAWS is cutting expenses, and things are getting better. It was noted that 2 Regions in the US provide 40% of the membership donations.
4. Globally, the Fellowship has seen significant growth in the past 2 years. There has been a spike in new meetings worldwide, while the growth rate in the US has flattened.
5. NAWS is reaching out to the Regions on a 1 on 1 basis by assigning 1 WB member as a liaison to each Region. Each WB member has 7-9 Regions assigned to them. We are encouraged to call our WB member before the RSC for the latest information.

6. The membership survey will remain on-line till the end of the year.
7. The first 2 Chapters of "Living Clean: The Journey Continues" are available on-line for review and input. There has been little input so far...
8. A worldwide workshop is scheduled for Boston, Massachusetts, 20–22 November 2009. Plans for workshops in Japan and the Middle East are under way.

Workshops:

There were 3 workshops on Saturday. The first was "Our Freedom, Our Responsibility". Next was "Our Service System", followed by "Living Clean: The Journey Continues". The attendance and the content of the workshops were both a little disappointing.

MZF Meeting:

1. The MZF approved the new and improved MZF website unanimously. It has been activated. You can see it at <http://www.mzfna.org/>
2. The Chicagoland Region will host the MZF meeting on Feb. 5-7. This will be a CAR and CAT review. There will be a NAWS update on Friday evening, and the CAR and CAT reviews will be on Saturday and Sunday from 9:00am – 5:00pm.
3. The MZF nominated Mark G. (Chicagoland Region) as a WSC Co-facilitator. Mark was not present to speak for himself. He sent his resume and letter of intent by email. This nomination did not come out of his home Region. While his resume is extensive, there was much discussion about the lateness of the nomination, and why the nomination did not come from his home Region. It seemed as though it was being rushed through at the last minute. We were not comfortable with this and voiced our objection. After more discussion and explanation, we withdrew our objection and stood aside.
4. We raised the topic of funding Trusted Servants. We asked for a discussion on the topic. It was decided to table the discussion until October at WSNAC. This seemed like a timely decision, as it will allow many more of our members the opportunity to attend and participate in the discussion. The MZF meetings are open to all members. This discussion will likely take place on Sunday at WSNAC.
5. The subject of Regional seating at the WSC was discussed. There is currently a moratorium on seating any new Regions that split from existing Regions. There will be a discussion at the WSC on this topic. There seems to be a movement to limit the number of participants at the WSC by having Zonal Forums represent the Regions. We feel that it is important for us to have a discussion at the RSC before the WSC, so that we will have clear direction on this when we get there.
6. The MZF will meet at WSNAC. The schedule includes the Rural Recovery workshop on Saturday from noon to about 3:00pm, in 2 sessions. Following the workshop, the MZF will meet until about 6:00-pm. The meeting will reconvene on Sunday morning at 9:00am with a recovery meeting and a business meeting from 10:00am till 2:00pm.

CAR Review:

We would like to begin scheduling CAR Reviews with the Areas beginning in November. The CAR comes out on or about November 25. We would also like to schedule a preliminary CAR review as a part of the January RSC. We will be at the Midwest Zonal Forum in February for a formal CAR review. At the March RSC, the Delegate Team will be asking for a final review and direction from the RSC on specific topics.

Delegate Team Report Addendum

NAWS was contacted by an organization called MATI. (Milwaukee Addiction Treatment Initiative) MATI is a collaboration among more than 80 state and local organizations—including law enforcement, public health agencies, treatment providers and advocates—to expand access to drug and alcohol treatment in Milwaukee County for everyone who needs it. This contact was passed along to us for follow-up.

"Milwaukee County currently suffers from a substantial "treatment gap"—the difference in the number of people who need treatment for drug and alcohol abuse and those who actually receive it. In 2004, the last year for which we have data, more than 82,000 people needed but did not receive treatment for drug and alcohol addiction in Milwaukee County. A recent study showed that in Wisconsin, 21 percent of individuals

age 18-25 needed but did not receive treatment for alcohol use, compared to 17 percent nationally. Nationally, roughly 10 percent of people who need treatment receive it."

MATI partners will attempt to close the addiction treatment gap through:

?? **Advocacy for reforming treatment funding and parity:** MATI will work to ensure that everyone in Wisconsin has health insurance that includes mental health and addiction coverage on a parity basis.

?? **Facilitating improved treatment delivery:** MATI will play a lead role in helping to integrate the delivery of addiction treatment services in Milwaukee County with mental health services, other health services, and employment, housing and other supportive services. Additionally, MATI will work to improve services for people suffering from addiction so that they are identified appropriately, assessed accurately, and receive timely and ongoing treatment as needed.

We were advised by NAWs Public Relations that "...it is not without precedent for NA to act in an advisory capacity to organizations with related purposes. NAWs at times participates in Recovery Month Planning Partners meetings, and both the Northern California and Southern California Regions have a presence at the California Department of Corrections' Twelve Step Advisory Board meetings. These presences serve to provide NA's perspective on matters and to let the groups know what NA can and cannot do, but refraining from giving advice to the organization, voicing opinions on outside issues, or engaging in advocacy. The value is primarily to communicate and cooperate with community partners. I am telling you this in case your region was interested in participating in something similar. If done in harmony with our guiding principles, this might be a valuable PR opportunity for Wisconsin NA. We'd be interested to hear about what action your region decides to take on this inquiry. Let me know if there's anything we can do to assist."

I attended a preliminary meeting with the Program Coordinator and Communications Director, at which our position on outside issues and advocacy were made clear. I left them with a set of books and IP packets. Chris and I both attended a meeting of the Communications Group in Milwaukee. We both feel that it is important for us to develop this relationship, as it has almost unlimited Public Relations potential on both local and state levels. We also feel that while it is important to maintain a Regional presence, much of the PR work can be done at the local level. One important contact was developed as a result of that meeting. We now have a rack of literature at the Public Defender's Office.

The Communications group meets monthly. I attended the September meeting. It was announced that MATI was going to tour the state, visiting local communities for briefings. We have been asked for contacts in other parts of the Region.

Dear Family, The website has moved to its new home on Hostmonster. The webservants are finding it necessary to reload the event fliers linked to the calendar. Everything seems to be working well now. We found it necessary to extend our stay with our old service provider for 1 month. One of our Webservants paid for the additional month of hosting as well as paying for our new hosting, and wishes to consider it a 7th Tradition contribution to the Fellowship. Many thanks go out to the Webservants. Moving the site and getting it fully operational has been a difficult, time consuming task.

National Rural Institute Conference (NRIADA): I spoke with the organizers of NRIADA. They do not charge an extra fee for workshop presenters. In fact, just the opposite is true. The NRIADA actually pays a fee for presentation. So, you might ask, "How does this work?" Since we are already paying a \$300 fee for our exhibit table, and they would pay us for the workshop presentation, they are willing to waive the exhibit fee in return for our presentation, if we are approved.

I also spoke with NAWS about a presentation. We agreed that a 1 ½ hour Special Topic presentation would

be the best way to start. If it goes well, we can try for the 4 ½ hour Mini-workshop in 2011. I was sent a workshop profile and customized it for NRIADA. Dear WRSC family: Addicted called Greg it has truly been fun heading up this ad-hoc committee. First, let me thank all those who shared their opinion on several occasions that we veered off the intended purpose of this ad-hoc committee. However, we still managed to have a healthy discussion and great ideals were flushed out. Hopefully, I have captured everyone's suggestions and ideals. First, off I share the view as one of our trusted servant that stated: "That should not be only the rich that can serve in Narcotics Anonymous. Having said that I believe somehow it is our responsibility to explore every opportunity to assist our trusted servants for their service in the event of financial hardship. I myself have experienced such a hardship this cycle that almost prevented me being here today.

The very first ideal was keep things just the way there are and offer assistance to individuals on case to case basis. This due to financial strain that is already on our budget, second proposal to this body was given by another member of this fellowship the plan would be to pay for two (2) rooms per cycles for the trusted servants to share a male room and female room. Our current budget allows \$900.00 for conference participation this ideal would only cost \$400.00 for one night and double that cost for two rooms, which is still a considerable savings to the region. This would offset the costs to the Facilitator team, Secretary Team, Treasurer Team, RD team, and still have room for Sub Committee Chairs or RCM's if needed. Also, another idea was to have all trusted servants include travel into their annual budget.

Another suggestion was to only make donation to world twice a year after the third and sixth cycle still using the current criteria. Still another idea is to have the RCM's to encourage their area to donate 57.00 dollars each cycle. That would cover our conference participation cost for the entire year. We could also raised the 50.00 conference participation allowance to reflect the current cost of living. I believe I have shared everyone's ideas and suggestions. So this committee will take direction from this body on the steps.
